### **Privacy and personal data**

Nina Bakery Europe respects your privacy and does not collect or process any personal data, unless you have provided these data to us. This means you can visit this website anonymously. We only use data provided explicitly and voluntarily by persons who visit our website.

We strive to respect and protect your privacy in the best way possible. In this privacy statement, we would like to explain to you what data we collect and why we do this.

### **Cookie policy**

First of all, we use Google Analytics to track how visitors use our website. For this purpose we use cookies. The information obtained, including your computer's address (IP address), is then transferred to and stored by Google on servers in the United States.

Google uses this data to track how our website is being used, to provide reports about the website to us and to offer their advertisers information about the effectivity of their campaigns. The information is anonymized as much as possible: your IP address is not used and we do not have access to individual-level data.

Google can provide this data to third parties if Google is legally required to do so, or when third parties process this data on behalf of Google. Nina Bakery Europe unfortunately has no influence here.
